1.6 DELIVERY, STORAGE AND HANDLING

- A. Finish containers are to be delivered to the project site in original, unopened containers.
- B. Storage temperature should not be different from normal conditions of an occupied space, between 45 ° F (7 C) and 80° F (26 C), with relative humidity not to exceed 85%.
- C. Before using, allow containers to achieve room temperature and normal relative humidity.

2.2 WALL PANEL FINISHING

- A. Semitransparent Stain:
 - 1. Ingredients: Brazilian Rosewood Oil, Tung Oil, Soy Resins and Vegetable Esters
 - 2. Color: Semitransparent warm light brown when wet, clear when dry.
 - 3. Gloss Level: Matte
 - 4. Flash Point: 200° F/93 C

 - 5. Viscosity: 184 cTs6. Stability: N/A if can is unopened
 - 7. Density: 7.8 lb/gal
 - 8. VOC: <1 g/l lb/gal
 - 9. Coverage: 350 500 square feet/gal
 - 10. Maximum Cure: 100% in 4-7 days
 - 11. Drying Time: 4 hours/ Serviceable: 12 hours
 - 12. Acceptable Product: Penofin® Verde, as manufactured by Performance Coatings, Inc. No substitutions permitted.

PART 3 - EXECUTION

3.1 EXAMINATION

- A. Ensure the wood or bamboo is clean, dry and free of surface materials.
- B. Ensure interior temperatures meet the ranges required for application of the finish.

3.2 PREPARATION

- A. Stir finish thoroughly before and during application.
- B. Do not apply if wood or bamboo is hot.
- C. Protect, tarp or mask off any adjacent areas not being finished.

3.3 APPLICATION

- A. Comply with the instructions and recommendation of the finish manufacturer.
- B. Use brush, pad or pump sprayer to apply liberal coating of surface.
- C. Allow finish to penetrate for 10-20 minutes. After 10-20 minutes, wipe the surface thoroughly with clean, lint-free cloths to remove excess finish.
- D. Soak any wiping and application brushes and pads in a bucket of water.

3.4 PROTECTION

- A. After application, protect wall panels from damage during any subsequent work.
- B. Do not allow trades to work in the immediate area until the finish is dry (Serviceable level: 12 hours).
